RE: Joint Request Regarding Winter Moratorium

Dear Companies:

As you know, the regulations of the Department of Public Utilities ("Department") prohibit electric and gas companies ("Companies") and municipal gas and electric departments, corporations, and plants ("MLPs") from shutting off service from November 15 through March 15 ("Moratorium"). G.L. c. 164, § 124F; 220 CMR 25.03(1)(a)(3). On October 21, 2025, National Consumer Law Center, Massachusetts Community Action Agencies, Massachusetts Energy Directors Association, Low-Income Energy Affordability Network, the Commonwealth's investor owned gas and electric utilities, the Office of the Attorney General, and the Executive Office of Housing and Livable Communities jointly requested that the Department advance the beginning of the Moratorium to the soonest possible date—no later than November 1, 2025—and to extend the Moratorium to April 1, 2026.

These requesters state that the on-going federal government shutdown has delayed the allocation of Low Income Home Energy Assistance Program ("HEAP" or "LIHEAP") funds to Massachusetts families. The requesters relay that the shutdown has introduced uncertainty to the regular LIHEAP funding cycle to Massachusetts community action agencies, who are now without assurances regarding their ability to rehire seasonal staff, process applications and notify clients and utility companies of HEAP energy assistance grants. In the normal process, the Companies would then protect those HEAP-eligible low-income customers from disconnection prior to and during the Moratorium. Additionally, the parties request an extension of the Moratorium to April 1, 2026, while temperatures are still cold.¹

The Department agrees that advancing the beginning date and extending the termination date of the Moratorium at this time will mitigate the harmful effects of the federal government shut-down on Massachusetts customers and will enable a consistent message among utilities and advocates, which will assist low-income households to meet their financial obligations while protecting them from shut-offs in cold weather. That message includes the importance of making payments during the winter months and avoiding the accumulation of large arrearages. Therefore, the Department approves the joint request and asks that as of Monday, October 27, 2025, your company or MLP refrain from initiating the termination process until April 1, 2026. More specifically, we request that second requests for payment pursuant to 220 CMR 25.02(3)(b) not issue until April 1, 2026 or later.

The Department notes that it has extended the Moratorium past March 15th in recent years. Relatedly, on June 24, 2025, due to an Extreme Heat Warning issued by the National Weather Service, the Department requested that the Companies and MLPs offer the protections afforded in the Moratorium to prevent customer shut-offs during a period when temperatures exceed an unhealthy heat threshold.

The Department appreciates your cooperation in extending the Moratorium in previous years. Thank you in advance for your anticipated continuing cooperation.
